TRAIL PACE DETAILS

The course itself is approximately seven expertly marked miles through beautiful Tewksbury township. The varied terrain includes hills, rocky areas, road crossings and water crossings.

The four divisions for this year's pace are: Open and 90 Plus (combined age of any two riders on a team is 90 years or older) Pleasure Pace or Trail Pace. Registration is open between 8:00 and 12:30, but riders must finish the course by 2:30 to be eligible for prizes. Event preparations and prizes are sponsored by local businesses and generous landowners. **Please remember:**

- Pick up after your horse and remove manure from parking area
- Ride along the edges of the fields
- · If you knock down a jump, dismount and set it back up
- Passing horses have the right of way, please be courteous and walk
- Water station at mid-point
- ALL RIDERS MUST WEAR ASTM/SEI certified helmets
- Current coggins required for all participating horses
